**I CRIMINAL & TRAFFIC COSTS:**

1. Standard Court Costs Traffic Moving Violations	\$110.00**
2. Standard Court Costs 2nd Case for Traffic Moving Violations	\$110.00**
3. Standard Court Costs for Traffic Non Moving Violations	\$60.00**
4. Standard Court Costs for Traffic Seatbelts	\$70.00**
5. Standard Court Costs for Criminal Cases (Felony/Misdemeanors)	\$110.00**
6. Standard Court Costs for 2 <sup>nd</sup> Case Criminal Misdemeanor	\$110.00**
7. Deposit on Criminal Complaint	no charge

**II OTHER MISC. CRIMINAL and TRAFFIC COSTS and FEES**

1. Capias and Warrants for Arrest issued as a result of a defendant's or probationer's failure to appear for any court proceeding will incur additional court costs of	\$25.00
2. Driving Letters issued to defendants charged with OVI, or probationers convicted of OVI	\$50.00
3. Drug tests fees:	
(a) In house test (urine)	\$25.00
(b) Outside lab tests	\$90.00
4. Deferred Payment Plans for Fines & Costs	
(a) 30 day deferral (contractual)	no charge
(b) 180 day deferral (contractual)	\$30.00
5. Expungement & Sealing of Records	

(a) Dismissed Cases & Acquittals (per each case expunged)	\$40.00
(b) Convictions (per each case sealed)	\$60.00
6. Certified Copies of Documents	\$5.00
7. Motion for Continuance	no charge
8. Appeal Fee (\$150.00 will be billed by Common Pleas Court)	\$50.00
9. License Block Fee – failure to appear	\$25.00
10. IDSF Bail Bond Fee	\$25.00
11. Public Defender Affidavit of Indigence Fee	\$25.00
12. Case Transferred to Capital Recovery	\$50.00
13. Bind Over Fee	no charge
14. NSF Fee	\$25.00

### **III PROBATION and DIVERSION SUPERVISION COSTS:**

1. Probation imposed as part of a criminal or traffic case sentence will incur the following monthly costs, unless otherwise ordered:

(a) Reporting Probation	\$40.00
(b) Non-reporting Probation	\$30.00
2. Diversion supervision by the Probation Department ordered in criminal or traffic cases will incur a monthly cost of \$40.00.
3. Charges of Violation of Probation or Diversion terms will incur additional costs of \$10.00.
